

POLICY STATEMENT:

The South Carolina Illegal Immigration Reform Act (S.C. Code Ann.59-101-430) prohibits those unlawfully in the United States from attending a public institution of higher education in South Carolina and from receiving a public higher education benefit. The South Carolina Illegal Immigration Reform Act requires all public institutions of higher education to verify that all students are lawfully present in the U.S.

Students claiming to be United States citizens can verify their citizenship status by completing either the **U.S. Citizenship Form** or **DTC Admission Application** and must provide one of the following:

List A	Valid driver's license or state – ID		
List B	Valid driver's license or state – ID	Birth Certificate	Valid US Passport
List C	Valid ID issue by a federal, state, or local government agency	Certificate of Citizenship	Certificate of Naturalization

If you are a US citizen, you must also submit one of the following:

- SC Driver's License or Identification Card issued after 1/1/2002
- Valid Driver's License or Identification Card issued from any of the following states: Alaska, Arizona, Connecticut, Delaware, Florida, Georgia, Idaho, Indiana, Kansas, Kentucky, Maine (issued after 11/15/08), Maryland, Massachusetts, Michigan, Missouri, Montana, New Hampshire, New Jersey, North Carolina, Pennsylvania, Rhode Island, Tennessee, Texas, Virginia, West Virginia, Wisconsin
- Valid U.S. Passport
- Social Security Card and valid photo ID
- Certificate of U.S. Citizenship (N-560 or N-561) and valid photo ID
- Certification of Naturalization (N-550 or N-570) and valid photo ID

Students who are not United States citizens must provide appropriate documentation and will be verified through the Department of Homeland Security's Student Exchange Visitors Information System (SEVIS) or Systematic Alien Verification for Entitlements (SAVE) database.
